Determining a patient's ability to safely reside in their own home or drive can be difficult without objective data. Both the High Level ADL and DORA meet these needs by providing valuable information related to the patient's physical, cognitive, and visual capabilities. This insight can then be utilized when making decisions for the individual and during difficult discussions with them and their family. Utilize the table below to determine what assessment will give you the valuable information you need to meet your patients needs!

RT-2S Reaction Time Tester: <i>Tests accelerator to brake reaction time</i>	RT-2S Reaction Time Tester: <i>Tests accelerator to brake reaction time</i>
Appropriate candidate for this assessment: Appropriate referral for this assessment would include individuals who have had a cognitive/memory decline and input is needed on their ability to maintain independent living.	Appropriate candidate for this assessment: Appropriate referral for this assessment would be individuals purely concerned about their ability to continue to drive safely.
Insurance coverage: Insurance coverage IS an option for this assessment IF patient has an appropriate diagnosis including cognitive decline (R41.81), memory deficit (R41.3), mild cognitive impairment (G31.84), cognitive deficits following cerebral infarction (I69.319), memory deficits following cerebral infarction (I69.911). This assessment can be completed as a cash pay service if indicated but a supporting diagnosis is not present.	Insurance coverage: Insurance coverage is NOT an option. This evaluation tool is offered as a PRIVATE PAY option only.
